This Trial is open to Adults, Youth A & B competitors who hold a SACU trials registration card, an ACU registration card or an FIM National Federation Licence with valid Start Permission and insurance.

VENUE: Old Cambusbeg Quarry, approximately 2 miles south of Callander on A84
TIME: Assemble 10.30am. 11.00am start
COURSE: Three laps, 12 sections, 2 routes, A & B, all on private ground.

SUPPLEMENTARY REGULATIONS. (please read carefully)

1. No "Fun bikes" or non-competitive bikes will be allowed on the ground.
2. "NON-STOP" method of marking will be used.
3. Trials Registration Card or Licence **MUST** be shown when signing on at the start.
4. Method of deciding ties:- most cleans, if still tied – most 1s, most 2s, etc.
5. Sections will be closed by a back marker. Time will be advised at riders briefing, along with any final instructions.
6. All competitors riding combustion engine machines must have a cut out device connected to the rider by a lanyard, maximum length 1 metre, so as to stop the engine should the rider and machine be parted. (With the exception of machines fitted with external magnetos)
7. Riders **NOT** competing in the Championship, can choose to ride as a Clubman on either Route A or B
8. **Helmet Cameras** are **not** permitted. Cameras attached to the machine are allowed, subject to permission from the Clerk of the Course.
9. Parents or Guardians of youth(s) signed on must NOT leave the ground.
10. Protests must be received in writing within 5 days of publication of results accompanied by a £100.00 protest fee.
11. Riders must keep to the flagged route.
12. **ENTRY CLOSING DATE:** FRIDAY 6th March 2020
13. **IN ORDER TO ACCRUE POINTS IN THE CLASSIC CHAMPIONSHIP A RIDER MUST PRE-ENTER EACH ROUND OF THE CHAMPIONSHIPS. (See SACU 2020 classic trials regulations, page 13 paragraph 5)**

Declaration: I the undersigned apply to enter the event described above in the consideration of:-

1. I hereby declare that I have had the opportunity to read, and that I understand the National Sporting Code of the ACU/SACU, the ACU/SACU standing regulations, such Supplementary Regulations as may have been issued for the event, and agree to be bound by them.
2. I further declare that I am physically and mentally fit to take part in the event and I am competent to do so.
3. I confirm that I understand the nature and type of event I am entering and its inherent risk and agree to accept the same notwithstanding that such risks may involve negligence on the part of the organisers or officials.
4. I accept that insurance arranged on my behalf by the organisers of events that I may enter specifically excludes liability between the participants. I understand that this form may be used in litigation as evidence that any serious injury will be principally the result of my voluntary decision to engage in high risk activity.
5. I consent to details of any injuries I may suffer at this event being passed between all medical services and the Clerk of the Course/ Secretary of the Meeting.
6. I further agree that the machine(s) as described below which I compete on shall be suitable and proper for the purpose.
7. I confirm that if any part of the event takes place on a public highway, the machine(s) described overleaf shall be insured as required by the Road Traffic Acts, or equivalent legislation, and that it/they will comply with the regulations in respect thereof.
8. I understand and agree that I am required to register my arrival by signing on at the race control office or other designated area, not less than 30 minutes prior to commencement of my practice or first competition, whichever occurs first.
9. I confirm that I have not been refused an SACU/ACU licence, nor had an SACU/ACU licence suspended, nor have I been excluded from any SACU/ACU competition.
10. I confirm that I am not currently suspended from SACU/ACU competition, or on the ACU/SACU Stop list as a result of incurring a Concussion injury. Further, I shall notify the Club should I incur such a suspension or concussion injury between now and the event.

Acknowledgement of the Risks of Motorsport

I understand that by taking part in this event I am exposed to a risk of death, becoming permanently disabled, or suffering some other serious injury and I acknowledge that even in the event that negligence on the part of the ACU/SACU, the Promoter, the organising Club, the venue owner, or any individual carrying out duties on their behalf were to be a contributory cause of any serious injury I may suffer, the dominant cause of any serious injury will always be my voluntary decision to take part in a high risk activity.

I have read the above and acknowledge that my participation in motorsport is entirely at my own risk.
